- Only the following 10 tests are approved for the career promotion grants. The Ministry of Health, Labour and Welfare Human Resources Development has reviewed the examiner, test content, test method, the curriculum such as training courses that are required to take the exam.
- Career consultants, with human resource settings, support career choice and self-development in line with aptitude, experience, and the like. A career consultant is an expert on career development assistance in corporate, public and private employment agencies, schools, etc., and is needed in a wide range of fields. The Employment Counsellor who has passed the national test is a qualified career consultant (primary-grade 2). , ② career consultants who pass one of the 10 tests listed are permitted to carry out the jobs such as personnel and education personnel of companies, temporary staffing, recruitment company employees, Hello Work counselors, other school career guidance personnel, various consultation service personnel, management personnel consultant, financial planner, social insurance labor consultant, etc.
