## Treasurers' Report (Roberta Neault)

- FY 2014 net income of \$13,600
- Net assets: \$12,186 at year end
- (including start-up loans)
- Roberta commended Marilyn Maze for her management of the budget, start up costs and our assets. The financial support of Marilyn and Soonhoon made a big difference to the initial stability of the organization.
- We need to attend to partner groups who can support and increase our registration income. We are also looking to secure additional large sponsors and vendors.
- Increased in membership also supports our balance sheet. The legacy donation/sponsor was also significant. Our expenses were less at the conference budget so that supports.
- Japan conference will also attempt to be as cost effective as possible.
- We now have Umbrella Insurance but need to fund Director's Insurance to sustain the Board and cover personal liability.
- Membership renews a year from when one joins (365 days).

## **Country Reports**

## **Australia, Andrew Rimington**

- The Australian Government budget decision in May 2014 to remove funding for labour market transition programs for disadvantaged groups such as youth came into affect as at end December.
- The related removal of the Government's contribution of \$2.4 million to long term careers products such as the Job Guide and the MyFuture web site will be implemented as of 2015.
- Key stakeholders have been working with Education Services Australia (MyFuture manager) to develop sustainable models for State and Territory Governments to consider for co-investment.
- The Australian Chamber of Commerce & Industry convened a Career Development
   Stakeholder Forum in December with industry representatives, senior
   Departmental decision makers from Education, Employment and Industry portfolios, as well as key stakeholders such as Career Development Association of Australia and other

- Career Industry Council of Australia members and other peak bodies. The outcome is a working group to review current activities, identify gaps in service provision and provide recommendations to government.
- The Australian Government announced a Ministerial reshuffle late in December which
  include portfolio functions being reallocated across Departments with appointments of
  new Ministers and reallocation of portfolio responsibilities: this will require briefing new
  Ministers and advisers on the many issues related to the Australian career development
  sector.
