FINANCIAL UPDATES

Marilyn reviewed the balance sheet and conference expenses.

- Discussion about paying back Soonhoon for her loan of \$5000. Marilyn also paid expenses of \$913 that have not been reimbursed. Diana moved and Cheri seconded that loans from Soonhoon and Marilyn be paid back -50% this fiscal year and 50% next fiscal year.
- The Officers agreed that insurance which covers international board of directors would be for APCDA to have. Cheri moved that we pursue insurance for the board. Satomi seconded. Marilyn will continue to investigate the current costs. In 2013, this type of insurance was offered by a Canadian company for \$950.
- The largest part of the budget for this year is the conference, plus minor operational expenses. We are still trying to understand the conference expenses and potential income.
- Marilyn will reach out to past sponsors and vendors to see if they want to exhibit again. Shelley will
 also seek local vendors in Taiwan. PAC will be a vendor, perhaps a sponsor. Marilyn will create a
 Sponsor Flyer for Shelley to use in Taiwan.

Webinars 2016:

- We reviewed speaker/presenter evaluations from 2015 conference and identified some of the highest rated ones.
- Roberta Neault offered to provide a webinar for those in Nepal who could not attend the conference. Nepal would be the priority for 2016. Marilyn will reach out to them and ask if they want a webinar.
- Deb Osborne received the highest scores and would be easily ready to provide a webinar in the "CIP". This would be our second priority.
- Cheri recommended Danita, Lisa, and Sungsik. Nancy Author would be excellent if we could get her. Mary McMahon also gave some well-received presentations.

- We believe we can get an economist from the Asian Development Bank to speak on the workplace of the future, but the actual person has not yet been decided.
